Re: Notice of Intent and Claim of Right⁽¹⁾

The underwriter, :Yaprak-Ceyhan:Benderlioglu:©, De Jure Party, born with inherent rights, unemployed, homeless, hereby declares:

- 1) That a child was born on **28 May** and given the name **Yaprak** acknowledged by printout, **1971** Birth Certificate No. 35357 /71;
- 2) That a deceased estate (declared intestate) in the name of the Father created a transmitting utility for trade for which the **Birth Certificate/Bill of Lading BENDERLIOGLU/1971 Birth Certificate No. 35357** /71, was issued; and
- 3) That the Bailee in possession by entry, dishonestly and without Claim of Right has left the underwriter a vulnerable Adult subject to detention and attack by Mercantile Agents; and
- 4) The underwriter with clean hands in equity in accord and satisfaction **motu propria**, natural justice, and the maxim; **iniquum est ingenuishominibus non esseliberam rerum suarumalienmationem**, with the knowledge and approval declares this to be her Will and Claims⁽²⁾; that
- i. The record should now be corrected to show that the child born on 28 May 1971 and identified by Printout Birth Certificate No. 35357 /71 is now an adult, competent to testify, no longer a ward of the state, lost at sea, or a bastard devoid of her estate. The correction of the record Will Now reflect that the Child has attained the age of majority and acknowledges her property as not being abandoned [Ct] Cestue Que Vie Act 1966; and that
- ii. All are equal under the law and the only Laws that apply to Living, Breathing, Wo(men) of Flesh and Blood are the Laws of Creation, also known as the DIVINE LAWS, the Laws of Nature, and the Laws of the Universe, whereas STATUTES ARE FOR CORPORATIONS; and

- iii. That in commerce, truth is sovereign, therefore failure to provide full, complete and not misleading disclosure of EVERY CONTRACT, whether expressed, implied, adhesion, tacit or any other form, to ALL PARTIES to the contract renders them VOID, with all inherent rights restored, **ab initio** to the De Jure Party, and
- iv. That, as truth expressed by way of an affidavit, then all claims in this declaration must be rebutted point for point within SEVEN (7) days of receipt or by default **shall remain forever Binding**; and
- v. The underwriter, in knowledge that a Birth Certificate is a document outlining particulars of a LEGAL/CORPORATE PERSON⁽⁴⁾, can no longer be a PARTY to fraud and Will use a variant of the Identification Certificate as attached below; and

- 7) Lodged with the Registrar-General of Titles [Ct], Victoria, AUSTRALIA.
- 8) Any unlawful detention by Mercantile Agents will incur the charge outlined in the attached 'FEE SCHEDULE.'
