STATEMENT OF UNDERSTANDING

Whereas it is my understanding that the AUSTRALIAN GOVERNMENT is a Common Law jurisdiction; and

Whereas it is my understanding that the only form of government recognized as lawful in Australia is a representative one; and

Whereas it is my understanding that the power of the 'people' to choose their representatives is an inherent right written in the **Original**, and Lawfully valid Commonwealth of Australia Constitution Act 1901 sections 7 and 24; and

Whereas it is my understanding that representation requires mutual consent; and

Whereas it is my understanding that in the absence of mutual consent neither representation nor governance can exist; and

Whereas it is my understanding that equality before the law is paramount and mandatory; and

Whereas it is my understanding a statute is defined as a legislated rule of society which has been by CONSENT given the force of law; and

Whereas it is my understanding that a society is defined as a number of people joined by mutual consent to deliberate, determine and act for a common goal; and

Whereas it is my understanding that all Acts are statutes restricted to within a society in scope and applicability; and

Whereas it is my understanding that 'people' in Australia have a lawful right to revoke or deny consent to be represented and thus deny consent to be representatively governed; and

Whereas it is my understanding that if anyone does lawfully revoke or deny consent to be represented, they exist free of any representative government control and statutory restraints; and

Whereas it is my understanding that a by-law is defined as a rule of a corporation; and

Whereas it is my understanding that corporations are legal fictions and require contracts in order to claim authority or control over other parties; and

Whereas it is my understanding that legal fiction does not have a soul and cannot exert any control over those who are HUMAN BEINGS, the Children of God, and operate with respect to and of that knowledge, as only a FOOL would allow soulless fictions to dictate one's actions; and

Whereas it is my understanding that those who have an Australian Tax File Number are in fact employees of the AUSTRALIAN GOVERNMENT and thus are bound by the statutes created by the AUSTRALIAN GOVERNMENT; and

Whereas it is my understanding that it is lawful to relinquish or abandon one's account at the Australian Taxation Office and therefore the ACCOUNT NUMBER held for Person's at the said office thus terminating any employee related obligations; and

Whereas it is my understanding that is lawful for Natural Persons, but not mandatory, to relinquish or abandon one's account at the ATO to terminate any employee related obligations; and

Whereas a Freewoman-on-the-Land has lawfully revoked consent to be Representatively Governed and does exist FREE of any statutory restrictions, obligations, and limitations; and

Whereas, I, **:Yaprak-Ceyhan:Benderlioglu:©**, am a Freewoman-on-the-Land; and

Whereas it is my understanding that acting peacefully within community standards does not breach the peace; and

Whereas it is my understanding that any action for which one can apply for and receive a license must itself be a fundamentally lawful action; and

Whereas as I am a Freewoman-on-the-Land who operated with full responsibility and not a child, I do not see the need to ask permission to engage in lawful and peaceful activities, especially from those who claim **limited liability**; and

Whereas it is my understanding that a by-law is defined as a rule of a corporation; and

Whereas it is my understanding that corporations are legal fictions and require Contracts in order to claim authority or control over other parties; and

Whereas it is my understanding that legal fiction does not have a soul and cannot exert any control over those who are HUMAN BEINGS, the Children of God, and operate with respect to and of that knowledge, as only a FOOL would allow soulless fictions to dictate one's actions; and

Whereas it is my understanding that I have a right to use My property without having to pay for the use or enjoyment of it; and

Whereas it is my understanding that PUBLIC PROPERTY is in fact and actuality Public Property to which I have the right of use and access freely; and

Whereas I claim the right to collect the Pension which I have paid into it and claim that said right is not affected by the abandonment of my Australian Tax File Number; and

Whereas it is my understanding that a summons is merely an invitation to attend, and the ones issued by the Australian Securities Commission create no obligation or dishonor if ignored; and

As stated by Sir Harry T. Gibbs, former Chief of Justice of High Court of Australia;

“I therefore have come to the conclusion that the current legal and political system in use in Australia and its States and Territories has NO BASIS IN LAW.”
(Sir Harry Talbot Gibbs, GCMG, AC, KBE, QC (17 Feb.1917 - 25 June 2005), Chief Justice of the High Court of Australia from 1981 to 1987, cited from <https://cirnow.com.au/sir-harry-gibbs-statement/>)

Whereas it is my understanding that peace officers have a duty to distinguish between statutes and law and those who attempt to enforce statutes against a Freewoman-on-the-Land are in fact breaking the law; and

Whereas I have the power to refuse intercourse or interaction with peace officers who have not observed me breach the peace; and

Whereas permanent estoppel by acquiescence barring any peace officer or prosecutor from bringing charges against a Freewoman-on-the-Land under any Act is created if this claim is not acknowledged and responded to in the stated fashion and time.

CLAIM OF RIGHT

Therefore, be it now known to any and all concerned and affected parties, that I, :Yaprak-Ceyhan:Benderlioglu:©, a Freewoman-on-the-Land do hereby state clearly, specifically and unequivocally my intent to peacefully and lawfully exist free of all Statutory Obligations, State imposed Restrictions and maintain all rights at Law to Trade, exchange or barter.

Furthermore, I claim that these actions are not outside of my communities' standards, and I will in fact support said community in Our desire for truth and maximum freedom.

Furthermore, I claim the right to engage in these actions and further claim that all property held by me is held under this CLAIM OF RIGHT.

Furthermore, I claim that anyone who interferes with my lawful activities after having been served notice of this claim and who fails to properly dispute or make lawful counterclaim is Breaking the Law, cannot claim good faith or color of right and that transgressions will be dealt with in a properly convened Court De Jure.

Furthermore, I claim that the courts in Australia are De-Facto and bound by the Law and are in fact in the profitable business of conducting, witnessing and facilitating the transactions of security interests and I further claim they require the consent of both parties prior to providing any such services.

Furthermore, I claim all transactions of security interests require the consent of both parties and I do hereby deny consent to any transaction of a security interest issuing under any Act for as herein stated as a Freewoman-on-the-Land I am not subject to any Act.

Furthermore, I claim my FEE-SCHEDULE:

For any transgressions by peace officers, government principals or agents or justice system participants is; FIVE THOUSAND DOLLARS PER HOUR, or portion thereof and if being questioned, interrogated or in any way detained, harassed or otherwise regulated; TWO HUNDRED THOUSAND DOLLARS PER HOUR or portion thereof if I am handcuffed, transported, incarcerated or subjected to any adjudication process **without my express written and notarized consent**.

Furthermore, I claim the right to use a Notary Public or other available method to secure payment of the aforementioned FEE-SCHEDULE against any transgressors who by their actions or omissions harm me or my interests, directly or by proxy in any way.

Furthermore, I claim the right to order and direct the *Government Representatives* to transfer directly to me funds and moneys which they would normally transfer to my [Provincial]; [Regional District Council], representatives in the absence of any directives, if doing so is in my opinion, in my best interests.

Furthermore, I claim the right to convene a proper Court De Jure in order to address any potentially criminal actions of any peace officers, government principals or agents or justice system participants who have been served notice of this Claim of Right to dispute or discuss or make lawful counterclaim and then interfere by act or omission with the lawful exercise of properly claimed and established rights and freedoms.

Furthermore, I claim the Law of Agent and Principal applies and that service upon one is service upon both.

Furthermore, I claim the right to deal with any counterclaims or disputes publicly and in an open forum using discussion and negotiation and to capture on video tape said discussion and negotiation for whatever lawful purpose as I see fit.

Affected parties wishing to dispute the claims made herein or make their own counterclaims must respond appropriately within SEVEN (7) days of service of notice of this action. Responses must be made Under Oath or Attestation, upon Full Commercial Liability and penalty of perjury and registered in the Notary Office herein provided no later than SEVEN (7) days from the date of original service as attested to be way of certificate of service.

Furthermore, I Claim the [right and absolute ownership], to (all Property; corporeal; incorporeal; tangible or intangible; visible or invisible; exchangeable value); or which goest to make-up the (Wealth or estate), of :Yaprak-Ceyhan:Benderlioglu:© or YAPRAK CEYHAN™©.

Furthermore, I claim the [right and absolute ownership] to (all Heridiments; corporeal or incorporeal; the right to all property; corporeal or incorporeal; tangible or intangible; visible or invisible; real or Personal; everything that has an exchangeable value), or which goest to make up the (Wealth or estate), of [All my Ancestors];

Furthermore, I claim the right as the (Holder in Due Course); and (accept for value); my [Birth Certificate], [Birth Registration], [Certificate of Live Birth], [Certificate of Marriage]. Issued to me by the GOVERNMENT OF AUSTRALIA.

Furthermore, I claim the right [to use the funds]; either in (my Bond); (evidenced by the bond tracking number) on the [Birth Certificate], [Certificate of Live Birth], [Certificate of Marriage], issued to me by the [GOVERNMENT OF AUSTRALIA] or to use the [Funds], generated by (the bond); to either pay off any student load if I do have one, or to pay directly for my Education, if I do not have a loan.

Furthermore, I claim the right to use the [funds]; in the (bond); or [revenue], generated by those [funds], to pay for food and shelter and any other rights recognised by the United Nations.

Furthermore, I claim the right to terminate the employment of [anyone]; acting as a (fiduciary) over my bond if they fail to acknowledge all rights here-in claimed.

Furthermore, I claim the right to revoke or deny consent, to be represented, and in doing so, free myself from all statutory obligations and restrictions, if doing so, in my opinion, is in my best interests.

Furthermore, I claim the right to direct my fiduciary as to what to do with the revenue generated by my bond, provided the directives are a benefit to my society and me.

Furthermore, I claim the right as the [Progenitor] (Mother); of [my progeny] (descendant); and include my [progeny]; [within this Claim of Right]:

Born at MELBOURNE on the Seventeenth Day in the Month of April in the year of Our Lord Two Thousand and Seven.

These Rights are hereby lawfully claimed and protested and are established as LAW; on failure to discuss or dispute Any and All concerned parties wishing to discuss or dispute claims must send a Notice of Dispute or Offer of Discussion within SEVEN (7) days via Registered Mail to the C/O [Address provided].

Failure to register dispute against the claims made herein will result in an automatic default judgment and permanent and irrevocable estoppel by acquiescence barring the bringing of

charges under any statute or act against My Self, Freewoman-on-the-Land, :Yaprak-Ceyhan:Benderlioglu:© or against YAPRAK CEYHAN™©.

All parties who have been served proper Notice of this Claim of Right and fail to discuss or dispute and then infringe, violate or abrogate said rights directly or through their Agents, employees or proxies, agree they do so under full COMMERCIAL LIABILITY and further agree to pay me upon my demand a sum certain of ONE MILLION DOLLARS, for every infringement, violation or abrogation outside of the above Fee-Schedule.'

[This Claim of Right]; is made and served; with the intent; of bettering my society; myself; my progeny, without ill will, malice, aforethought, frivolity or vexation.
